



IV. Socio-Economic Condition

The client and her family lives in their own house made out of galvanized iron sheets and lumber that situated in Barangay Kayvaluganan, Basco, Batanes. Their family's only source of income is from her father as he works as fisherman that nets him an average of Ps.000.00 a month.

Client and her family do not have other source of income and their total family income is just enough to support their daily needs. Client and family are classified under family class "C".

v. Findings

The client is a first-year student taking up Bachelor of Science in Elementary Education at Batanes State College.

Based on the client's current socio – economic condition they do not have the enough capacity to meet the demands needed in her pursuit for tertiary education, taking into consideration the immense financial need ranging from miscellaneous fees, allowances and other educational expenses. Taking into consideration that they are under family class "C".

And since tertiary schooling requires a lot of monetary support, client seeks for assistance to aid her in the course of her study.
