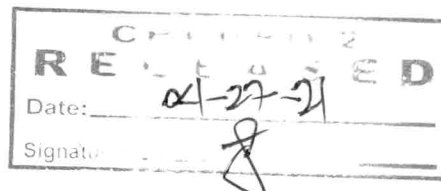

In view of the urgent appeals received by the UniFAST Secretariat from various Higher Education Institutions (HEIs) and students requesting an extension for the deadline of the submission of documentary requirements, please be informed that the deadline of submission of documentary requirements for Tulong Dunong Program (TDP) **is further extended from 23 April 2021 to 30 April 2021.**

The additional extension is to give ample time for the students to complete the documentary requirements and for the HEIs to submit the necessary documentary requirements of their respective list of **TDP applicants.**
