

In view of the urgent appeals received by the UniFAST Secretariat from various Higher Education Institutions (HEIs) and students requesting for another extension for the deadline of the submission of documentary requirements, please be informed that the deadline of submission of documentary requirements for Tulong Dunong Program (TDP) is once again extended for the third (3rd) time, from 30 April 2021 to 15 May 2021.

We fervently hope that the 3rd additional extension will be enough time for the students to complete the documentary requirements and for the HEIs to submit the necessary documentary requirements of their respective list of TDP applicants. Further extension of the deadline delays the validation, processing and disbursement of the TDP grants of the qualified students at no fault of the UniFAST Secretariat and the CHED Regional Offices.

The UniFAST Regional Coordinators are enjoined to disseminate this Memorandum to the concerned HEIs as soon as possible.
