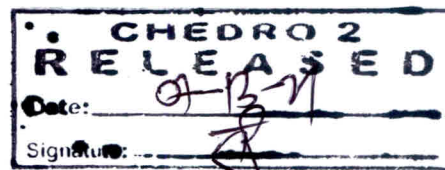

TO : ALL CHED REGIONAL DIRECTORS AND OFFICERS-IN-CHARGE

SUBJECT : AMENDMENTS TO SECTIONS 6 AND 12 OF CMO NO. 08, SERIES OF 2019 ENTITLED "POLICIES AND GUIDELINES FOR CHED SCHOLARSHIP PROGRAMS (CSPs)"

In accordance with the pertinent provisions of Republic Act (RA) No. 7722, otherwise known as the "Higher Education Act of 1994", and by virtue of Commission en banc (CEB) Resolution No. 371-2021 dated June 29, 2021, the hereunder amendment to CMO No. 08, series of 2019 is hereby adopted and promulgated for the guidance of all concerned stakeholders.

Specific provisions of CMO No. 8, series of 2019 is hereby amended to read as follows:

1) Article VI, CHED Scholarship Programs

Section 6. A qualified student may be awarded Full Scholarship or Half Scholarship under the State Scholarship and Private Education Student Financial Assistance (PESFA). The CSPs are intended for entering first year students who are eligible for college whose General Weighted Average (GWA) is **at least 96% or its equivalent for Full Merit Program and 93% to 95% or its equivalent for Half Merit Program**, who must enroll in recognized priority programs in private Higher Education Institutions (HEIs) or State Universities and Colleges (SUCs)/ or accredited Local Universities and Colleges (LUCs) with Certificates of Program Compliance (COPC). The availment of the type of scholarships is determined through ranking system and availability of slots.

2) Article X, Financial Assistance

Section 12. The financial assistance under this CMO shall cover **tuition and other school fees (TOSF), stipend which shall be released directly to the scholars or through HEIs, and book/connectivity allowance per semester** of a given academic year until the completion of the degree program. The approved proposed financial assistance package for the Full and Half Merit Scholars per semester are detailed as follows:

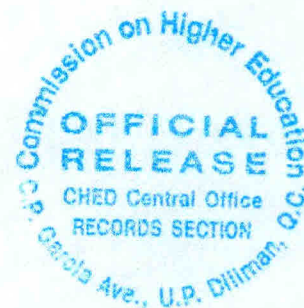

**SUBJECT: PRIORITY PROGRAMS FOR CHED SCHOLARSHIP PROGRAMS (CSPs)
EFFECTIVE ACADEMIC YEAR (AY) 2021-2022**

In accordance with Section 8(i) and 8(n) provisions of Republic Act (RA) No. 7722, otherwise known as the "Higher Education Act of 1994", in compliance with the annual General Appropriations Act (GAA), and by virtue of the Commission en banc (CEB) Resolution No. 360, Series of 2021, the Commission hereby issues these guidelines providing the list of priority programs for CHED Scholarship Programs (CSPs) effective Academic Year (AY) 2021-2022.

I. Rationale

The priority programs aim to direct/steer higher education qualified applicants for financial assistance under the CSPs to enroll in public or private higher education institutions (HEIs) offering recognized/authorized undergraduate priority programs.

The determination of the priority programs was the result of the discussions and deliberations conducted by the Technical Working Group (TWG) Members composed of representatives from CHED and UniFAST Secretariat in coordination with the Department of Trade and Industry (DTI), National Economic and Development Authority (NEDA), Technical Education and Skills Development Authority (TESDA), Department of Labor and Employment (DOLE), Department of Science and Technology (DOST), Professional Regulation Commission (PRC), Philippine Overseas Employment Administration (POEA), Philippine Chamber of Commerce and Industry (PCCI) and the Philippine Management Information System (PMIS), in line with the National Development Plan on manpower demands based on the JobsFit 2022 Labor Market Information (LMI) Report of DOLE.

Scholars who are enrolled in any of the priority programs listed in this CMO may avail of the benefits under the CSPs provided that the financial assistance under the Tertiary Education Subsidy (TES)-UniFAST will not be duplicated. In the case of scholars with financial assistance under the CSPs who are already enrolled in SUCs and LUCs and enjoying the benefits of Free Tuition and Other School Fees (TOSF) under R.A. No. 10931, they can still be granted financial assistance in the form of stipend the amount of which would depend on the type of CSPs they were able to qualify.

II. ALLOCATION OF PRIORITY PROGRAMS:

Percentage allocation based on national and regional cluster are as follows:

- Science & Mathematics - 15%
- Engineering & Technology - 15%
- Information Technology Education - 20%

NON-STEAM

- Business & Management - 10%
- Multi and Interdisciplinary - 10%
- Other Disciplines - 25%

● REGIONAL 5% 100%

B. Regional Priority Programs

For the effective implementation of this CMO, the CHED Regional Offices (CHEDROs) shall ensure that the Priority Programs herein listed are properly distributed according to the regional needs and availability of slots.

In order to ensure maximum utilization of slots, the Regional Director may exercise discretion in the distribution of slots among national and regional priority areas provided that it is within the percentage allotted to the region.

IV. Career Guidance

The CHED, in collaboration with the Department of Education (DepEd) and DOLE, shall intensify the promotion of identified priority programs through Career Guidance Advocacy Program (CGAP). For this purpose, all graduating beneficiaries of CHED StuFAPs are encouraged to register in the *PhilJobNet* (www.philjobnet.gov.ph), a government online job portal, in order to avail of the job search assistance and other employment facilitation services. The *PhilJobNet* also provides career information advice and other featured articles that the students may use as tools in making career choices.

V. Repealing Clause

All other existing Orders and Memoranda issued by the Commission, which are contrary to or inconsistent with any of the provisions of this CMO are hereby deemed repealed or modified.

VI. Separability Clause

If any part or provision of this CMO is declared invalid the remaining clauses/provisions not affected thereby shall remain valid and enforceable.

VII. Effectivity

This CMO shall take effect fifteen (15) days after its publication in the Official Gazette or in a newspaper of general circulation, and after filing the required copy thereof with the Office of National Administrative Register (ONAR) at the UP Law Center, UP Diliman, Quezon City and shall remain in force and effect until revoked or amended.
