However, to ensure maximum participation the afternoon workshops "Best Practices in Academic Collaborations" and "Best Practices and the United Nations' Sustainable Development Goals" will be limited to 45 participants. In this regard, we are requesting each CHED Regional Office to nominate three (3) mid-level HEIs, classified based on CHED Memorandum Order No. 55, series of 2016, to attend the workshops. Mid-level or Tier 2 HEIs are defined as select State Universities and Colleges or deregulated HEIs by evaluation with at least Level III program accreditation, pursues home-based internationalization activities, possesses well-defined typology, undertakes membership in international networks, has an established international relations office, international student center and quality assurance mechanism, and an internationalization program strategy. HEIs not classified under this category may view the afternoon session through the livestream.

Further, please inform IAS of the names of the 3 HEIs for verification purposes on or before 24 August 2020 through ias@ched.gov.ph.
