Pursuant to the Memorandum from the Executive Secretary dated September 21, 2021, with the subject, *Resumption of Limited Face-to-face Classes for Specific Programs of Higher Education Institutions (HEIs) in Areas under Modified General Community Quarantine (MGCQ)* and in support to the CHED-DOH Joint Memorandum Circular No. 2021-001 on the *Guidelines for the Gradual Reopening of Campuses of Higher Education Institutions for Limited Face-to-Face Classes During the COVID-19 Pandemic*, please be informed of the following programs with issued CHED Memorandum Order (CMO) for limited face-to-face classes:

1. CMO No. 18, series of 2021 on the Guidelines on the Conduct of Practicum Activities for **Bachelor of Science in Tourism Management (BSTM)** and **Bachelor of Science in Hospital Management (BSHM)**
2. CMO No. 19, series of 2021 on the Guidelines on the Conduct of Critical Workshop and Laboratory, Thesis and Capstone Design and OJT Courses of **Engineering and Engineering Technology Programs** During the COVID-19 Pandemic Period
 - Bachelor of Science in Agricultural and Biosystems Engineering
 - Bachelor of Science in Aeronautical Engineering
 - Bachelor of Science in Civil Engineering
 - Bachelor of Science in Chemical Engineering
 - Bachelor of Science in Computer Engineering
 - Bachelor of Science in Electrical Engineering

- Bachelor of Science in Electronics Engineering
- Bachelor of Science in Geodetic Engineering
- Bachelor of Science in Industrial Engineering
- Bachelor of Science in Mechanical Engineering
- Bachelor of Science in Metallurgical Engineering
- Bachelor of Science in Mining Engineering
- Bachelor of Science in Sanitary Engineering
- Bachelor of Engineering Technology

3. CMO No. 20, series of 2021 on the Guidelines on the Implementation of Flexible Learning Options and Gradual Reopening of Campuses for Limited Face-to-face Classes during the COVID-19 Pandemic Period for the **Bachelor of Science in Marine Transportation (BSMT)** and **Bachelor of Science in Marine Engineering (BSMarE) Program**

The above-mentioned programs are now included in the allowable programs for limited face-to-face classes for MGCQ areas only.


For tourism and hospitality management programs, limited face-to-face classes for internship/practicum shall be conducted only within the higher education institutions duly authorized by CHED to offer limited face-to-face classes and/or in Department of Tourism (DOT) - accredited hotels and other accommodation establishments operating as regular hotels as defined under relevant DOT guidelines.

The subjects or courses allowed for face-to-face delivery are delimited to specialized laboratory courses and internship/practicum as stated in the guidelines per program.

The application process stipulated in the CHED-DOH JMC No. 2021-001 shall apply.
