Pursuant to CHED Memorandum Orders No. 16, and 28, series of 2021, which approves the Scholarships for Staff and Instructors' Knowledge Advancement Program (SIKAP) Grant for Full-time and Part-time Study, CHED Regional Offices are directed to invite and accept applications for full-time and part-time study under the SIKAP Grant.

Interested applicants who wish to apply for a SIKAP Scholarship either on Full-time Study or Part-time Study must meet the eligibility criteria provided in Annex A (Full-time Study) and Annex B (Part-time Study).

For the Full-Time Study and Part-time Study, the CHED ROs are reminded to be guided by existing policies and government accounting and auditing rules on the period required to process and release allowances for approved scholars. CHED ROs may approve and issue the Notice of Award to eligible applicants **on or before 20 March 2022 only**.

The CHED ROs are instructed to process the applications and issue the Notice of Award immediately for applicants who are able to comply and meet the requirements of the scholarship upon submission of their complete and correct application documents on or before the deadlines mentioned above.

Furthermore, applicants who are able to qualify for the eligibility criteria and meet the terms and conditions of the scholarship except for the following eligibility requirements: (1) work load and study leave requirements **and/or** (2) admission to an eligible graduate program, will be classified as waitlisted applicants. Waitlisted applicants who are unable to comply after one (1) term will be automatically considered as ineligible and must re-apply for the SIKAP Grant Scholarship.

## Annex A. Eligibility Requirements for Full-time Study

- a. Filipino Citizen
- b. The applicant must undertake and complete her/his graduate studies in an eligible graduate program offered by any of the following:
  - i. Autonomous / Deregulated Institutions;
  - ii. State Universities and Colleges (SUC) designated as Level III or higher;
  - iii. Center of Excellence (COE) or Center of Development (COD);
  - iv. A program accredited as or whose equivalent undergraduate program is accredited as Program Level III or higher; OR
  - v. Mindanao State University (MSU) and its constituent units, or the University of the Philippines (UP) and its constituent units
- c. Applicant is Teaching or Non-Teaching Personnel who are employed or separated from service/discharged within 12 months from date of application, including those under the basic or technical education divisions or departments, by any of the following HEIs:
  - i. An HEI duly recognized by CHED; or
  - ii. An HEI duly recognized by the Ministry of Basic, Higher and Technical Education (MBHTE);
  - iii. Local Universities and Colleges (LUCs) with Institutional Recognition (IR) issued by CHED;
- d. For those employed, must have an approved study leave for full-time study from the start of the scholarship and for the duration of study or, an issued certification of deloading of teaching units/work responsibilities/assignment from the Head of the Human Resource Office or its equivalent and attested by the HEI President or its equivalent;
- e. For those previously employed:
  - i. Must be separated from service/discharged within the last twelve (12) months at the time of application;
  - ii. The separation from service/discharge was not due to an administrative charge, dismissal or just causes<sup>1</sup> as attested by a certification issued by the Head of the Human Resource Office of the previous employer
- f. Must be physically fit and mentally prepared to undertake and complete graduate work as supported by a medical certificate;
- g. Age is not more than 50 years old within 6 months from the date of application (i.e. will not turn 51 in the next 6 months from date of submitted application);

<sup>&</sup>lt;sup>1</sup> Just Causes - refer to those instances enumerated under Article 297 [Termination by Employer] of the Labor Code, as amended. These are causes directly attributable to the fault or negligence of the employee. (DOLE DO No. 145-15); Article 297 of the Labor Code: An employer may terminate an employment for any of the following causes: (a) serious misconduct or willful disobedience by the employee of the lawful orders of his employer or representative in connection with his work; (b) gross and habitual neglect by the employee of his duties; (c) fraud or willful breach by the employee of the trust reposed in him by his employer or any immediate member of his family or his duly authorized representative; and (e) other cases analogous to the foregoing.



# Annex B. Eligibility Requirements for Part-time Study

- a. Filipino Citizen
- b. The applicant must undertake and complete her/his graduate studies in an eligible graduate program offered by designated Delivering Higher Education Institutions (DHEIs) which are:
  - i. Autonomous/Deregulated Institutions;
  - ii. State Universities and Colleges (SUC) designated as Level III and above;
  - iii. Center of Excellence (COE) or Center of Development (COD);
  - iv. A program accredited as or whose equivalent undergraduate program is a accredited as Program Level III or above; OR
  - v. Mindanao State University (MSU) and its constituent units or the University of the Philippines (UP) and its constituent units
- c. Applicants must be Teaching and Non-Teaching Personnel including those under the basic or technical education divisions or departments, who wish to pursue and complete a graduate degree on PART-TIME STUDY. They must be existing personnel of any of the following HEIs with a plantilla/regular item, including those with temporary appointment or those with contract of service/contractual employment status:
  - i. An HEI duly recognized by CHED;
  - ii. An HEI duly recognized by the Ministry of Basic, Higher and Technical Education (MBHTE);
  - iii. Local University and Colleges (LUCs) with Institutional Recognition (IR) issued by CHED
- d. Employment Status of Applicants
  - Full-time Faculty or HEI Personnel with plantilla/tenured items with minimum performance rating of "Very Satisfactory" or its equivalent in the past three (3) years of continuous service to the sending higher education institution (SHEI) at the time of application;
  - Full-time Faculty or HEI Personnel with temporary or probationary appointments with minimum performance rating of "Very Satisfactory" or its equivalent for the past one (1) year in the SHEI;
  - iii. Contractual or Contract of Service HEI Personnel with Full-Time Equivalent Teaching Load / Work Load with existing contract with the SHEI at the time of the application with a minimum performance rating of "Very Satisfactory" or its equivalent at the time of application for the past one (1) year;
  - iv. Part-time Contractual or Contract of Service Faculty with an existing contract with the SHEI at the time of the application and have continuously served the SHEI as full-time/part-time faculty for 3 cumulative academic years (AY) with a minimum performance rating/Student Evaluation of Teachers (SET) of "Very Satisfactory" or equivalent
- e. For applicants classified under D1, D2 and D3, the proposed thesis/dissertation is aligned with the research and development agenda of either the SHEI and/or DHEI as attested by the HEI President or its equivalent;
- f. Must secure a permit to study from the SHEI President or its equivalent and duly endorsed by the Faculty and Staff Development Committee or its equivalent;



- g. Must be physically fit and mentally prepared to undertake and complete graduate work as supported by a medical certificate;
- h. For applicants classified under C1 and C2, age is not more than 50 years old within 6 months from the date of application (i.e. will not turn 51 in the next 6 months from date of submitted application);

# Annex E. Scholarship Privileges

## A. Full-time Study<sup>2</sup>

- a. Successful applicants to the SIKAP Grant are entitled to the following scholarship privileges for the term when their application was approved by CHED and/or compliance to the terms and conditions of release of scholarship privileges.
  - i. Actual cost of tuition and other school fees;
  - ii. Monthly living allowances, disbursed on a per academic term basis;
  - iii. A yearly book and other resources allowance;
  - iv. A yearly transportation and communication assistance;
  - v. Thesis / dissertation allowance.

- SIKAP Grant Scholars may also avail of the following additional supports, subject to availability of funds:
  - i. Student Research Support Fund
    - Research Support Grant to provide additional funding for the conduct of thesis and/or dissertation research apart from the outright assistance provided in Section C, No. 1 of the Handbook for Full-Time Study. The eligibility of the research support grant includes:
      - a. The research submitted for the additional support must be recommended by the adviser and the Dean for further funding, subject to the evaluation of a technical expert identified by the Commission.
      - b. The scholar must be on compliant status.

- Publication incentive(s), for up to two (2) papers, to be claimed upon publication in a refereed, ISI-Index, Web of Science, or Scopus-Listed Journal provided that the scholar is the sole or lead author. The publication incentive may only be availed up to one (1) academic year after graduation, including scholars on approved one (1) year extension, subject to availability of funds.
- For the DHEI Model, mentor's fee and incentive for scholars who are able to finish the degree on time. The DHEI must provide a certification regarding the assigned mentor of the scholar, and shall take charge of the disbursement of the fee / incentive in accordance with this section.
- Early Completion Incentive for scholars who are able to complete their degree programs at least one (1) regular term ahead of the approved original study plan. The scholar must provide documentation of the same.

  - a. Reimbursement of one (1) round-trip economy ticket in lieu of the travel allowance;
  - b. Living allowances following a tier-system according to the host country for the months, or any fraction of a month greater than seven (7) days, wherein the scholar resides in the host country.

## B. Part-time Study<sup>3</sup>

- a. For SIKAP Grant Scholars who are full-time faculty or HEI personnel with Plantilla/Tenured/Regular items or temporary or probationary appointments, the following are the scholarship privileges to be availed:
  - i. Actual tuition and other fees shall be billed by the DHEI to CHED;
  - ii. The student subsidy shall be released on a per academic term basis, subject to compliance to documentary requirements for release of financial privileges.
  - iii. Mentor's fee is only available for scholars who are able to finish the degree within the original approved study plan. The DHEI must provide a certification regarding the assigned mentor of the scholar, and shall take charge of the disbursement of the fee / incentive in accordance with the policy.
