#### BRIEFER

The DTI Region 02 invites all research practitioners and enthusiasts to participate in the 1<sup>st</sup> Cagayan Valley CMCI Regional Research Conference with the theme "Competitive and Innovative LGUs: Toward an Investment-Ready Cagayan Valley".

The theme aims to provide recommendations that shall:

- Inspire the Local Chief Executives to be more proactive in their espoused responsibility of achieving genuine change for the people they govern by driving local economic development and competitiveness, and integrating innovative strategies in their locality; and
- Introduce strategic actions and investment-friendly policies that will improve the overall competitiveness of the cities and municipalities in the region as it impacts the regional competitiveness and investment climate of the Cagayan Valley Region (based on the 5 Pillars of the CMCI – Economic Dynamism, Government Efficiency, Infrastructure, Resiliency and Innovation)

The Cities and Municipalities Competitiveness Index (CMCI) Survey is an annual ranking of different cities and municipalities in the country based on a tool developed by the NCC with the assistance of the USAID. The framework of the CMCI is drawn from the goal to make the country more globally competitive by measuring local competitiveness based on five major criteria: economic dynamism, government efficiency, infrastructure, resiliency, and innovation.

Every year, massive number of data is collected from different LGUs based on the CMCI indicators that reflect the LGUs' competitiveness level. These data, when fully maximized and analyzed will provide a clear picture of the level of competitiveness of the LGUs, of the regions and of the country as a whole; will identify areas for improvement and growth; and introduce reforms and initiatives to boost and improve local competitiveness.

#### **OBJECTIVE:**

The activity aims to utilize the CMCI data in providing useful information, informative conclusions and sound recommendations that will improve the regional competitiveness- and- investment- climate- of- the- Cagayan--Valley; through- data-research and analysis

#### PARTICIPANTS:

The 1<sup>st</sup> CMCI Cagayan Valley Regional Research Conference is open to all, whether individual, private and public sector or academic institutions **from Region 02**, that are interested in government policy research and proposals. The researcher/s can be individual or group (maximum of 3 members).

#### **RESEARCH CONFERENCE COMPONENTS:**

The Research Conference has 2 components, to wit: *First Component: Call for Research Papers* 

- <u>Call for Entries</u> Invitation letters will be sent to the HEIs in Region 02; and at the same time, will also be posted in DTI-R2s official FB pages. Interested participants will have to accomplish an Intent to Participate Form within the given deadline.
- Submission of Research Title and Abstracts Interested participants are required to submit a proposal that include the Title of the Research Study and an Abstract related to the research topic.
- <u>Review of Entries</u> Research Titles and Abstracts will be reviewed by esteemed researchers (board of adjudicators) that will be invited from other Regions. The Board of Adjudicators will select entries that will proceed to the next stage.
- 4. <u>Submission of Research Papers</u> Selected entries will be notified and will be required to submit full research papers that contain the following parts: Introduction, Methodology, Results and Discussion, and Bibliography.

#### Second Component: Regional Research Conference

Five (5) research papers will be presented in the 1<sup>st</sup> Cagayan Valley CMCI Regional Research Conference. There will be an allotted time for each presentation, and the Board of Adjudicators will judge the research papers based on its content, relevance, and organization. Three (3) best research papers will be recognized/awarded.

  - Inspire the Local Chief Executives to be more proactive in their espoused responsibility of achieving genuine change for the people they govern by driving local economic development and competitiveness, and integrating innovative strategies in their locality; and
  - Introduce strategic actions and investment-friendly policies that will improve the overall competitiveness of the cities and municipalities in the region as it impacts the regional competitiveness and investment climate of the Cagayan Valley Region
