In connection with numerous appeals received by the UniFAST Secretariat from Higher Education Institutions (HEIs) and various regions, please be informed that the Secretariat *will be accommodating appeals relating only to TES-1 and TES-2 received only on or before April 29, 2022 for the 1st semester of AY 2021-2022. Further extension won't be allowed due to budgetary constraints.*

Subsequently, please be informed that with the Memorandum dated March 7, 2022, the UniFAST Secretariat specified the final deadline of validation for TES 1st Semester on March 11, 2022. The UniFAST Secretariat provided an ample window period for HEIs to review the validation results and submit appeals, if any, to the CHED Regional Offices to accommodate and validate issues/appeals, as stipulated under the JMC No. 04, S. 2020 below.

XX. Complaints and Grievances

- **8.7.** The appeal shall be filed within ten (10) working days from the publication of the list of HEIs with TES student-grantees.
- **8.8.** Failure to file an appeal within the period is deemed a waiver of the right to file the same.

We fervently hope that the ample periods given are sufficient for HEIs and CHEDROs to have reviewed and confirmed the roster of grantees. Given the budgetary constraints, and



the provisions under XX. Complaints and Grievances, Section 8.8. above, appeals on the specified semesters will no longer be accommodated.

In this regard, the UniFAST Regional Coordinators are hereby requested to immediately disseminate this Memorandum to the concerned HEIs and instructed to expedite the validation and verification process of documentary requirements following the timeline of activities shown below:
