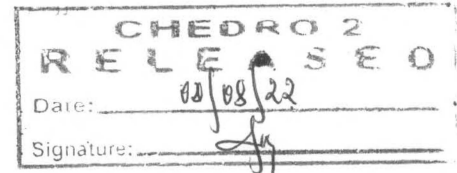



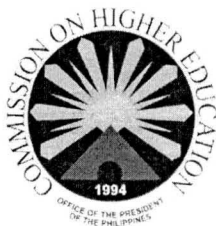

Pursuant to Section VI of CHED-DOH Joint Memorandum Circular (JMC) No. 2021-004 or the Guidelines on the Implementation of Limited Face-to-face Classes for All Programs of Higher Education Institutions (HEIs) in Areas Under Alert Levels System for COVID-19 Response, all CHED Regional Offices (CHEDROs) are tasked to lead on-site inspections of HEIs which will apply for safety seal and are conducting limited face-to-face classes and closely monitor the status on the implementation of limited face-to-face classes and COVID-19 cases for tertiary students and HEI personnel conducting limited face-to-face classes.

In line with this, the Commission will be issuing the CHED Memorandum Order (CMO) on the Guidelines on the Safety Seal Certification Program for Higher Education Institutions (HEIs) to serve as a guide for HEIs on the application process for the Safety Seal Certification and for CHED Regional Offices on the issuance of the Safety Seal. The launching of the CHED Safety Seal website <www.safetyseal.ched.gov.ph> is scheduled on **08 April 2022 (Friday), 1:00 - 3:00 PM, via Zoom Video Conferencing.**

With this, we are extending this invitation to our Philippine Higher Education Institutions to attend the official website launch on the aforementioned date. We also encourage our CHED Regional Offices in disseminating this invitation to our partner Philippine HEIs.

The HEI representatives may register through <https://tinyurl.com/CHEDSafetySealLaunch>. Due to the limited number of slots in the Zoom meeting room, only one (1) participant per institution should register and will be admitted to the online meeting. Other members and non-registered attendees may tune in to the CHED Facebook Page (<https://www.facebook.com/PhCHED.gov>) on the same date and time for the live streaming.
