CHED Regional Offices are reminded to strictly adhere with the deadlines provided above and to observe existing policies and government accounting and auditing rules. Processing of applications and issuance of Notice of Award must be done without delay for applicants who comply and meet all the eligibility requirements of the scholarship. It is expected that the issuance of Notice of Award will only be given to applicants who are found to be eligible and with complete and correct documentary submissions on or before the deadlines mentioned above.

Applicants who are able to qualify for the eligibility criteria and meet the terms and conditions of the scholarship except for the following eligibility requirements: (1) work load and study leave requirements and/or (2) admission to an eligible graduate program, will be classified as waitlisted applicants. Waitlisted applicants who are unable to comply within the term will be automatically considered as ineligible and must re-apply for the SIKAP Scholarship.
