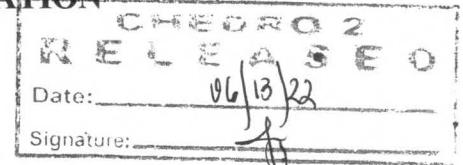

SUBJECT : CALL FOR PARTICIPANTS IN THE "SPECIALIZED TRAINING ON ETHICS FOR PUBLIC AND PRIVATE HIGHER EDUCATION INSTITUTIONS (HEIs) (STEPP-HEIs): CAPACITATING PUBLIC AND PRIVATE HEIs ON APPLYING ETHICAL PRACTICES IN THE ACADEME AND IN THE CONDUCT OF SOCIAL SCIENCE RESEARCH"

Attached is a copy of the memorandum issued by **DR. J. PROSPERO E. DE VERA III**, Chairperson, Commission on Higher Education, organized by CHED, University of the Philippines, and the Philippine Social Science Council, informing interested parties from the Higher Education Institutions for the *"Specialized Training on Ethics for Public and Private HEIs (STEPP-HEIs): Capacitating Public and Private HEIs on Applying Ethical Practices in the Academe and in the Conduct of Social Science Research"*.

The training program aims to capacitate selected public and private HEIs to undertake ethical social science research and to assist in their establishment of an internal research ethics review board. The participants will be asked to complete the monthlong training (with one class per week) by batch.

CHED Regional Office Directors and Officers-in-Charge are expected to identify and endorse the participating HEIs and representatives based on the following criteria:

Criteria for HEIs

1. HEIs with research centers or units whose primary function is the conduct of research or provision of research services; and
2. HEIs without an existing research ethics review board or committee.

Criteria for representatives from the identified HEIs

1. A faculty member or researcher actively engaged in producing research, has produced publications or has attended or presented papers in training and conferences;
2. A faculty member with the rank of Assistant Professor or higher, with Master's or Doctoral degree;
3. A faculty member who has been serving the university or college for at least three years;
4. Both genders should be represented;
5. A prospective member of the Ethics Review Board or Committee or any other similar research ethics evaluation body to be established by the HEIs social science unit or college;
6. A research adviser of the HEIs social science unit or college; and

7. A faculty member who teaches research ethics, research methods, or related courses in the HEIs social science unit of college.

For those who meet the criteria above, please submit to CHEDRO 2 office your documents on or before **June 14, 2022** for proper endorsement.

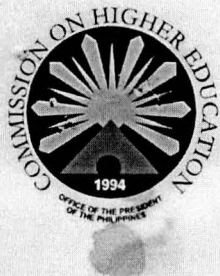

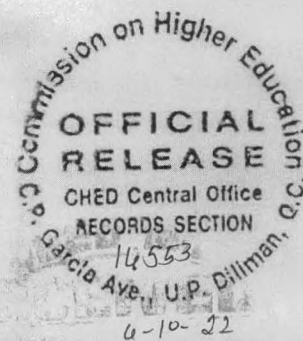
