

On July 6, 2021, the Commission en banc approved the proposal of the Office of Programs and Standards Development (OPSD) through the Technical Panel for Teacher Education (TPTE) and the Office of the Oversight Commissioner for Teacher Education pursuant to CEB Resolution No. 414-2021, to conduct a Three-part Scoping Study for Philippine Teacher Education which intends to accomplish the following objectives:

- 1. Examine the current context of admission and retention of students in teacher education programs in relation to larger issues of teacher quality;
- 2. Evaluate the quality of provisions of pre-service teacher education vis-à-vis the outcomes of the licensure examination for teachers (LET); and
- 3. Explain the relationship of emerging leadership and management approaches in TEIs that create a culture of quality and excellence in teacher education.

For Study No. 01 – An Exploration on the Quality of Teacher Education Institution Entrants, the Implementing TEI is the University of Southeastern Philippines, and in view of the conduct of the said study, the proponent is **seeking the assistance of our regional offices** to contact the identified TEIs for their respective responses.
