Attached is a copy of the Memorandum from Dr. J. Prospero E. De Vera III, Chairman, Commission on Higher Education, regarding the Resolution of the Commission on the concerns of Indian Medical Student-Applicants relative to the National Medical Admission Test (NMAT) requirement for entry inro Philippine Medical Schools.

The Commission en Banc (CEB) Resolution No. 445-2022, that without setting a precedent, resolved to suspend, in the case of the affected Indian medical student-applicants, the requirement of NMAT before the entry to medical schools and the NMAT cut-off score of at least 40<sup>th</sup> percentile for one (1) academic year (AY 2022-2023) in order to conditionally accept/admit the affected Indian medical student-applicants in the respective Philippine medical schools, subject to the following:

- Before entry to the medical school, Indian medical student-applicantsshall be subjected to rigid admission requirements (e.g., mandatory admission test) to be implemented in lieu of the NMAT as a quality indicator and predictor of a student's academic performance in medical school; and
- Indian medical student-applicants are still required to take the NMAT within a period of one (1) year.

In view of this, the CHED Regional Office 2 is directed to monitor the entry of Indian medical student-applicants in the Doctor of Medicine program of above mentioned HEIs.

This is with reference to the communication from Estrada and Aquino Law, who is representing the concerned twenty-one (21) medical schools in the Philippines, requesting for the Commission to:

 Intervene on the recent rules and regulations of the National Medical Council (NMC) of India, which in essence effectively bar/restrict entry or admission of Indian students in the Philippine medical schools, which affects the Indian students who are currently enrolled in the Philippine medical schools and the completion of their degree programs; 2. Suspend the imposition of the National Medical Admission Test (NMAT) to Indian medical students due to the following:

- a. Many of the Indian medical students abroad cannot take the NMAT online as most of them come from remote areas with no internet connectivity. This scenario coupled with the extreme difficulty in traveling to testing areas on specific schedules set by the Center of Educational Measurement, Inc. (CEM) invariably disenfranchises the students, and in the end, even those who can register for testing could not complete the process and therefore, invalidating testing results and all efforts gone to waste;
- b. Each school has its own criteria for admission, which in the name of academic freedom and institutional autonomy will suffice in determining whether or not students may be accepted into the medical degree program and have the potential to complete the course; and,
- c. Although most countries of origin have screening procedures for their citizens to apply to medical schools abroad, specifically for the Indian medical students, a very stringent screening examinations such as the National Eligibility Examination Test (NEET) which is heavy in the sciences (i.e., Biology, Anatomy, Mathematics) is a top requirement.

The Commission en Banc discussed the said concerns during the 582nd Joint Management Committee and Commission en Banc Meeting held on 30 August 2022, and through CEB Resolution No. 445-2022, that without setting a precedent, resolved to suspend, in the case of the affected Indian medical student-applicants, the requirement of NMAT before the entry to medical schools and the NMAT cut-off score of at least 40th percentile for one (1) academic year (AY 2022-2023) in order to conditionally accept/admit the affected Indian medical student-applicants in the respective Philippine medical schools, subject to the following:

- a. Before entry to the medical school, Indian medical student-applicants shall be subjected to rigid admission requirements (e.g., mandatory admission test) to be implemented in lieu of the NMAT as a quality indicator and predictor of a student's academic performance in medical school; and,
- Indian medical student-applicants are still required to take the NMAT within a period of one (1) year.

As such, all CHED Regional Offices concerned are directed to monitor the entry of Indian Medical student-applicants in the Doctor of Medicine programs of the following medical schools in relation to the above decision of the Commission:
