In view of the request of all the applicants to extend the deadline required in the memorandum issued by the UniFAST OIC Executive Director on September 05, 2022 relative to the implementation of the Tulong Dunong Program (TDP-TES), the UniFAST Secretariat approved the re-opening and extending the validation for Academic Year 2021-2022.

Relatively, the UniFAST Regional Coordinators shall endorse Annex 2 or the Certified List of New TDP Applicants to the respective Higher Education Institutions (HEIs) of the applicants on October 12, 2022 - October 14, 2022.

In line with this, the HEIs are enjoined to notify and facilitate the submission of documentary requirements stipulated in the quidelines of the said program for the 1st Semester of Academic Year 2021-2022.
