HEIs shall submit their forms along with a letter from the HEI Head certifying the completeness and correctness of the submitted data via email to chedro2@ched.gov.ph, copy furnished cbrutas@ched.gov.ph, not later than December 22, 2022. HEIs may refer to the attached template for the endorsement of the HEI Head.
