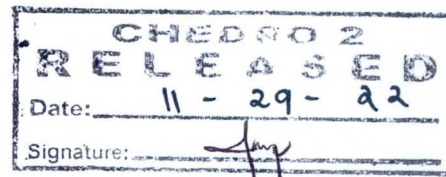

Date : **28 November 2022**

In connection with the Memorandum dated November 2, 2022 from the Office of the Executive Director which specified the final deadline of validation for TDP Continuing 1st Semester on November 9, 2022, please be informed that the UniFAST Secretariat will be accommodating appeals received **on or before December 7, 2022 for the 1st semester of AY 2022-2023. Further extension won't be allowed due to budgetary constraints.**

This will give an ample window period for HEIs to review the validation results and submit appeals, if any, to the CHED Regional Offices to accommodate and validate issues/appeals.

We fervently hope that the given period is sufficient for HEIs and CHEDROs to have reviewed and confirmed the roster of grantees. Given the budgetary constraints, appeals on the specified semester will no longer be accommodated.

In this regard, the UniFAST Regional Coordinators are hereby requested to immediately disseminate this Memorandum to the concerned HEIs and instructed to expedite the validation and verification process of documentary requirements.
