"SUPPORTING THE CULTURAL RECOVERY AND RESILIENCY PROGRAM 2022-2028 OF THE NATIONAL COMMISSION FOR CULTURE AND THE ARTS

WHEREAS, Republic Act No. 7356 mandates the National Commission for Culture and the Arts (NCCA) to formulate and implement policies for the development of Filipino national culture and arts, coordinate cultural policies and programs, and encourage artistic creation within a climate of artistic freedom;

WHEREAS, the Philippine Development Plan (PDP) and the Regional Development Plan (RDP) provide for the promotion of Philippine Culture and Values by strengthening mechanisms to measure and evaluate efforts for cultural development;

WHEREAS, in 2020, the culture and arts sector was one of the most affected sector by the COVID 19 pandemic as many of the artists and cultural workers have lost their source of income;

WHEREAS, in support to the government's interventions to address the effects of COVID-19 pandemic on Philippine culture and arts sector, a Cultural Recovery and Resiliency Program (CRRP) 2022 to 2028: "Towards Developing and Strengthening the Culture of Response and Resiliency in the Philippines" was formulated and approved by the NCCA Board of Commissioners per Resolution No. 2021-298 in May 2021";

WHEREAS, the CRRP aims to enable the culture and arts sector to adapt to and effectively recover from COVID 19 pandemic and disasters, fueled by good governance toward sustainable development and the protection and fulfillment of rights of multi-cultural communities;

WHEREAS, the program adheres to crosscutting principles of: (i) mainstreaming gender equality and social inclusion; (ii) integrating environmental protection and adaptation to climate change; and, (iii) application of human rights-based approach to implementation after the sector's advocacy in respecting, protecting, and fulfilling economic, political, and socio-cultural rights;

WHEREAS, the RDC2-Social Development Committee-Sub-Committee on Culture (SDC-SCC) during its 2nd Semestral Virtual Meeting on November 29, 2022 recognized the need to further strengthen culture development, thus

favorably endorsed to the Regional Development Council the CRRP 2022-2028 for support and adoption;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, to support the Cultural Recovery and Resiliency Program 2022-2028 of the National Commission for Culture and the Arts;

RESOLVED FURTHER, that copies of this Resolution and the CRRP 2022-2028 be forwarded to concerned agencies and institutions for support and appropriate action.
