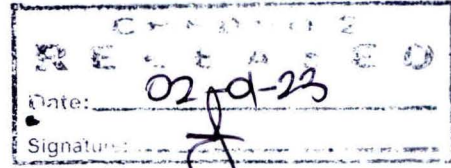

3. Making plans for NSTPIA activities.


