AMENDMENT TO ARTICLE IV.E OF CHED MEMORANDUM ORDER NO. 09. SERIES OF 2022 ON LOCAL OFF-CAMPUS ACTIVITIES

Pursuant to CEB Resolution No. 003-2023, Article IV.E. of CHED Memorandum Order (CMO) No. 09, series of 2022, or the "Updated Guidelines on the Implementation of Face-to-face Classes to Prevent and Mitigate COVID-19 Infections in Higher Education" is hereby amended to provide as follows:

XXX

"IV. GENERAL GUIDELINES

E. Local Off-Campus Activities

Local off-campus activities including but not limited to educational tours, degree program-relevant events, field study, mission-based activities, seminars/conferences, community outreach programs, performances, competitions, are allowed subject to compliance of HEIs with the provisions of CMO No. 63, series of 2017 otherwise known as the Policies and Guidelines for Local Off-campus Activities.

Other activities undertaken outside HEI premises and not covered under CMO No. 63 s. 2017 such as internship, practicum, and on-the-job training are allowed subject to compliance of HEIs with separate and existing CHED guidelines for the program concerned.

The HEIs are encouraged to coordinate with their partner institutions to allow unvaccinated students to participate in off-campus activities."

All other provisions of CMO No. 09, series of 2022 that are not affected by this amendment shall remain valid and enforceable.
