

The Annual CCET Orientation for this year aims to (1) support the President's 8-point socioeconomic agenda; and (2) the implementation of climate change provisions in the Philippine Development Plan 2023-2028.

## **Annual Climate Change Expenditure Tagging (CCET) Virtual Orientation for FY 2024 National Budget Preparation**

08 March 2023

### **I. Background**

The Climate Change Commission (CCC) and the Department of Budget and Management (DBM) led the institutionalization of Climate Change Expenditure Tagging (CCET). The CCET under the Joint Memorandum Circular (JMC) 2015-01 provides guidelines in tracking and reporting government agencies' climate-tagged budgets.

Section 5.3.5 of the above-mentioned JMC mandated the CCC together with DBM to strengthen the capacity of national government instrumentalities<sup>1</sup> to undertake CCET. Annually, the CCC and DBM conduct regular CCET orientation as part of the national budget preparation for the next fiscal year.

In 2020, the CCET Orientation was improved through (1) the inclusion of the Risk Resiliency Program (RRP) in the discussion of climate budget tagging; (2) the shift to a virtual platform that increased agency participation; and (3) the coordination with oversight agencies DENR, GCG, and CHED<sup>2</sup>.

For FY 2024 National Budget Preparation, the CCC shall continue the delivery of an online CCET Orientation together with DBM, DENR, GCG, and CHED.

### **II. Objectives**

The CCET virtual orientation will provide the latest information on climate budget tagging for national government planning, budget, and climate change officers.

The objectives for this orientation are as follows:

- Strengthen the capacity of national institutions to mainstream climate change into their PAPs using CCET typologies;
- Outline basic elements of planning processes to deliver climate action;
- Secure a better understanding of the formulation of climate actions and its linkage to the budget and planning process through national strategies and action plans;
- Ensure enhanced compliance with the CCET JMC and the relevant DBM's National and Corporate Budget Memoranda;
- Improve the understanding of roles and responsibilities of institutions involved in managing the Country's response to climate change;
- Quantify climate change-related allocation in the national and corporate budget;
- Guide the participants through the process of tagging and submitting to the CCET Help Desk CC PAPs in the context of national planning and programming process and the rationalized planning process; and
- Provide convergence across national government agencies on the implementation of climate change and disaster risk reduction programs, activities, and projects through the Risk Resiliency Program
