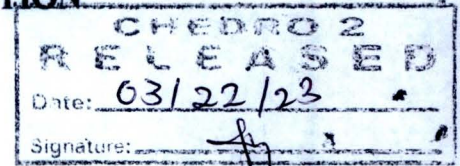

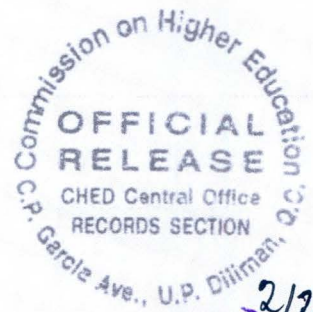



The Fulbright Foreign Student Program is a scholarship opportunity for Filipinos to study at the graduate level (master's and doctoral studies) or pursue a non-degree doctoral dissertation research in the United States. The scholarship program covers tuition and fees, settling-in-allowance, monthly maintenance allowance, books and supplies allowance, in-transit allowance, health and accident insurance, round trip international airfare, and excess baggage allowance.
