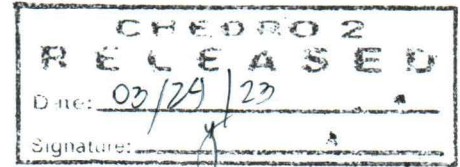

Greetings from the International Affairs Service!


