BALAKAD

(Beneficial Activities Leading to Awareness and Knowledge Against Drugs):

A UNIFIED INTERVENTION PROGRAM FOR THE CONDUCT OF DRUG TESTING AMONG HEIS IN REGION 2

A. RATIONALE

The quality of life in general, health, academic and/or work performance are greatly affected by the individual's well-being due to the use and abuse of illegal or prohibited drugs.

Drug use remains high despite the blitz of the COVID-19 Pandemic. According to the United Nation Office of Drug and Crime (UNODC) 2022 World Drug Report, in 2020, an estimated 284 million people worldwide aged 15–64, majority of whom were men, had used a drug within the last 12 months. This corresponds to approximately 1 in every 18 people in that age group, or 5.6 per cent, and represents a 26 per cent increase on 2010, when the estimated number of people who used drugs was 226 million and prevalence was 5 per cent. In the Philippines, it is unfortunate that 41.25% of those belong to age 15 to 19 years old admitted in the facility-based treatment and rehabilitation facilities use drugs according to the Statistical Analysis of Dangerous Drugs Board (DDB) for Calendar Year 2021. This statistical analysis of the DDB is in congruence with the 2022 World Drug Report of the UNODC that more young people continue to use drugs and have higher levels of use compared with previous generations.

In the Philippines, various drug prevention and intervention programs are implemented under the auspices of the Dangerous Drugs Board (DDB) with its implementing arms such as the Philippine Drug Enforcement Agency, Philippine National Police and other relevant government institutions toward curbing the drug problem. The Commission on Higher Education (CHED) is one of the said agencies which doing its job through massive information dissemination programs to increase awareness in the ill-effects of using drugs. CHED also institutionalized the drug testing of students in tertiary education through the issuance of the CHED Memorandum Order No. 18, series of 2018, "Implementing Guidelines for the Conduct of Drug Testing of Students in All Higher Education Institutions". The said CMO provides that Higher Education Institutions must have mechanisms to promote healthy lifestyle to their students, promote a "drug free" campus, drug education, strengthen collaboration and partnership and ensure that drug testing policies are reasonable and not violative of the fundamental rights of the students including their personal privacy and dignity. It also provides that the drug testing is in accordance with the DDB Regulation Number 6, series of 2003 and Number 3, series of 2009 which is for the drug prevention and rehabilitation purposes. However, the said CMO only provides that if a student found to be drug dependent, the appropriate sanction, intervention, and/or rehabilitation, shall be imposed in accordance with the school's Student Handbook and other applicable laws, rules and regulations.

Most HEIs in region 2 have already submitted their institutional policy on drug testing of students however, there are lacking in terms of the intervention program and/or rehabilitation program. Hence, the birth of the Beneficial Activities Leading to Awareness and Knowledge Against Drugs or BALAKAD: A Unified Intervention Program for the Conduct of Drug Testing Among HEIs in Region 2.

B. OBJECTIVES

This proposed program has the main objective of formulating a unified intervention program as a result of the conduct of random drug testing among HEIs in region 2. Specifically, it aims for the following:

- a. Ensure that all HEIs in Region 2 implement a common intervention mechanism to students found positive and confirmed to be drug dependent.
- b. Unite all HEIs, whether public or private, for the implementation of Drug Testing;

- c. Ensure that each HEI has its own respective approved Drug Testing Policy;
- d. Coordinate with government and/or non-government agencies on the conduct of Drug Testing in HEIs;
- e. Ensure that sharing of best practices on intervention programs of all HEIs takes place;
- f. Monitor proper implementation of Drug testing and its effective intervention programs.

C. SCOPE

This proposed intervention program covers all students enrolled in HEIs in region 2 who are found positive as a result of drug testing and confirmed to be drug dependent who falls under the mild category based on the evaluation of the Department of Health (DOH).

D. DEFINITION OF TERMS

Terms and Concepts relevant to Random Drug Testing are already contained in CMO No. 18 series of 2018. For the purposes of this intervention program, the following terms are defined as follows:

After Care – this is the process where the HEIS has to look into or follow-up on the student who has undergone the intervention program. The purpose of the after care is to assure that the student that went through the BALAKAD intervention program is completely now having a normal academic and social life within the HEI.

Appropriate Intervention Programs or Activities – these refer to the BALAKAD programs or activities that each HEIs would undertake after the administration of the needs assessment of a student found to be a mild user of illegal drugs through the implementation of random drug testing policy in the different HEIs of Region 2.

BALAKAD – is an intervention program crafted through the partnership of CHEDRO2 and the officers of the PREaCHERO2 who represents the different HEIs in Region 2. BALAKAD is the acronym for Beneficial Activities Leading to Awareness and Knowledge Against Drugs. Intervention programs herein mentioned in the documents would refer to BALAKAD.

Evaluation – is the process of holistically evaluating the implemented intervention program or activities of the BALAKAD. This process aims to look into how the program may be developed or improved.

Intervention — are therapeutic programs appropriate for students who are using dangerous drugs and are found to be in their mild stage and who are willing to take special assistance under the BALAKAD intervention program from the Higher Educational Institution of which he or she belong. The intervention program is a program crafted by the CHEDRO2 and HEIs of Region 2 through the PREaCHERO2 that may take the forms of crisis intervention, peer counseling, parent/student psychological counseling and other appropriate intervention activities deemed relevant and effective by each respective HEIs of Region 2.

Monitoring – is the process of checking not only the progress of the student under intervention but also to look into the efficiency or effectiveness of the intervention program or activity itself particularly in terms of logistics, facilities and implementation.

Needs Assessment – is the process of determining what possible intervention program or activities in the BALAKAD that maybe applicable for a student found to be positive of drug used at a mild level. This process of the intervention is done after an agreement is reached from both the parent and the student with the signing of an informed consent.


PrEaCHER02 — it is an organization of anti-illegal drug use advocates composed of representatives from different HEIs of Region 2 formed through the initiative of the anti-illegal drug focal person of the Commission of Higher Education of Region 2. PrEaCHER02 stands for Preventive Education and Capacity Building in Higher Education Region 02.

STARS — it stands for Student Trait Assessment for Responsible Self. This program provides psychological assessments along the areas of emotional quotient and Studying Attitudes of students. Students are personally monitored through timely intake interview, psychological assessment and counseling by a designated permanent counselor. A trait is a particular characteristic, quality, or tendency that someone or something has that can be assessed through one's emotional quotient and one's attitudes towards academic learning while in the university.

E. SCHOOL-BASED INTERVENTION PROGRAM PROCESS FLOW

The BALAKAD school-based intervention program is adopted by each HEIs in Region 2 upon the implementation of its drug testing policy, when a student was found to be positive of illegal drug used. Once a student is tested positive, a student has to undergo a confirmatory test through the Department of Health. Once the level of dependency is determined, the HEI concerned make sure to have a dialogue with the parents or guardian and the student to get their consent on the next step which is an intervention depending on the level of dependency. If the level is mild, the student and the parent may opt for the school-based intervention program through the BALAKAD by signing an informed consent. If the level is moderate and/or severe, the HEI may refer the student with his/her and parents' consent to proper rehabilitation agencies or to the LGU's Community Based Rehabilitation Program or CBRP.

The school-based intervention program has the following process flow:



F. SUGGESTED SCHOOL-BASED INTERVENTION PROGRAM

The PreaCHER-02 deems academic institutions as the efficient access of most efforts to develop and assess need-based approaches to adolescent drug abuse prevention. The proposed program targets salient risk and protective factors for adolescents diagnosed or identified as drug dependent guided by psychosocial theories for the employment of relevant and appropriate approaches in identifying and analysis on the attribution of the cause or reason for substance use and abuse. The data and knowledge gained from this work are deemed as the basis for developing practical or hands-on strategies.

The program comprises informative and therapeutic interventions arranged in a suitable sequence of the processes and activities designed according to the student drug dependents' needs and the intensity of these needs derived from the assessment conducted. Generally, the needs that are rated most important are the ones that get addressed. The activities will be designed to highlight the basic information or topics that the target population must know before the implementation of the need-based intervention to increase adolescents' awareness and knowledge against prohibited drugs and the social influences leading to drug abuse, educating them on specific skills for effectively battling the pressures of drug dependency, and providing them with therapeutic approaches to address their psychological, emotional, and psychosocial needs.



G. REFERRAL SYSTEM

The HEI once a student was tested positive must make steps to assure that the result is reliable through a confirmatory test with the Department of Health (DOH) for confirmation of the initial test and the determination of the level of drug dependency and to be able to know where to refer the student for possible intervention or rehabilitation. If the level of dependency is mild, then the student could be referred to the school-based intervention program but if the level of dependency is moderate and severe, the student may be referred for Community Based Rehabilitation Program.



H. Responsibilities/Role of HEIs, CHEDRO2 and other Stakeholders

Based on the objectives of this school-based intervention, the following are the responsibilities and roles of stakeholders:

CHEDRO2 - Shall

- 1) Ensure that all HEIs in Region 2 implement a common intervention mechanism to students found positive and confirmed to be drug dependent;
- 2) Unite all HEIs, whether public or private, for the implementation of Drug Testing;
- 3) Ensure that each HEI has its own respective approved Drug Testing Policy;

- Coordinate with government and/or non-government agencies on the conduct of Drug Testing in HEIs;
- Ensure that sharing of best practices on intervention programs of all HEIs takes place;and
- 6) Monitor proper implementation of Drug testing and its effective intervention programs.

HEIs of Region 2 – Shall

- 1) Ensure that it has its own respective approved Drug Testing Policy;
- Coordinate and collaborate with CHEDRO2 and PrEaCHERO2 for the implementation of Drug Testing;
- Ensure that it implements the common intervention mechanism to students found positive and confirmed to be drug dependent through the BALAKAD;
- Coordinate with government and/or non-government agencies on the conduct of its own Drug Testing; and
- Monitor proper implementation of its own Drug testing and its effective intervention programs.

PrEaCHER 02 - Shall

- serve as an arm of CHEDRO2 in the implementation of a common intervention mechanism to students found positive and confirmed to be drug dependent;
- 2) assist CHEDRO2 for the implementation of Drug Testing;
- help each HEI especially those who do not have yet their own respective Drug Testing Policy;
- 4) assist CHEDRO2 and HEIs in coordinating with government and/or non-government agencies on the conduct of Drug Testing;
- 5) collaborate with CHEDRO2 to ensure that sharing of best practices on intervention programs of all HEIs in Region 2 takes place; and
- 6) monitor the proper implementation of Drug testing and its effective intervention programs among PrEaCHER02 groups.

Other Stakeholders (DOH, PNP, PDEA, LGU, DSWD) - Shall

- collaborate with all HEIs in Region 2 in the implementation of the BALAKAD, a common intervention program, to students found positive and confirmed to be drug dependent;
- assist all HEIs, whether public or private, for the implementation of Drug Testing especially on referrals; and
- 3) coordinate with CHEDRO2 or HEIs in their jurisdiction on the conduct of Drug Testing;
