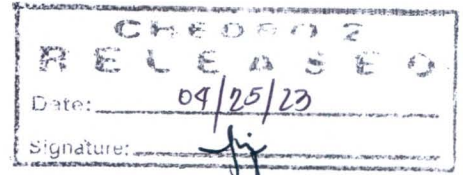

In accordance with the pertinent provisions of Republic Act (RA) No. 7722, otherwise known as the "Higher Education Act of 1994"; R.A. No. 7796 otherwise known as the "TESDA Act of 1994", R.A. No. 10647 of 2014, known as the "Ladderized Education Act and its Implementing Rules and Regulations (IRR)"; R.A. No. 10968 of 2018, known as the "Philippine Qualifications Framework Act," by virtue of the recommendation of the PQF-NCC Working Group on Pathways and Equivalencies composed of the Commission on Higher Education (CHED), Technical Education and Skills Development Authority (TESDA), Department of Education (DepEd), Department of Labor and Employment (DOLE), and Professional Regulation Commission (PRC); as approved by CHED Commission *en banc* (CEB) through Resolution No.498-2022 dated October 3, 2022, and TESDA, the Philippine Credit Transfer System is hereby adopted and promulgated jointly by the CHED and the TESDA.

Thus, the Philippine Qualifications Framework-National Coordinating Council (PQF-NCC), through the Working Groups for Pathways and Equivalencies, will conduct a face to face Zonal Public Orientation on the Philippine Credit Transfer System (PCTS). Details of the said zonal orientations, are as follows:

Relative to this, Heads/Presidents/Officers-In-Charge/Deans/Faculty Members/students of higher education institutions, relevant stakeholders, and CHED Regional Office Directors and/or Supervisors are invited to attend the said public orientations in the relevant zonal regions.


Due to the limited capacity of the venues, onsite participants are requested to register five (5) days before the scheduled zonal orientation through the links provided above to receive confirmation and acceptance. Participants who will not be able to attend onsite/ face to face orientation of the approved PCTS may visit the CHED Facebook page for the live stream or may join via zoom platform.

Funds for travel and other incidental expenses of the participants from the CHED Regional Offices (2 representatives per CHEDRO) will be transferred to their respective Offices. Participants coming from public HEIs shall be charged against their local funds subject to usual accounting and auditing rules and regulations. Participants from SUCs, LUCs, private HEIs and other stakeholders shall have to make arrangements on their travel expenses with their respective institutions.

Food during the zonal public orientations shall be provided by CHED. To ascertain logistical preparations, only one (1) representative per HEI shall be allowed to attend this activity via onsite/face to face. CHED Regional Offices are requested to forward confirmations of participants from their respective regions to CHED - Office of Programs and Standards Development not later than five (5) days before the date of public orientations.
