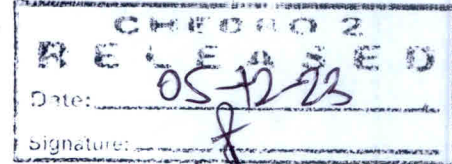

In the Senate hearing on the proposed Senate Bill No. 1551 - Mandatory Basic Reserve Officers' Training Corps (ROTC) Act conducted on 06 February 2023, CHED Chairman J. Prospero E.
