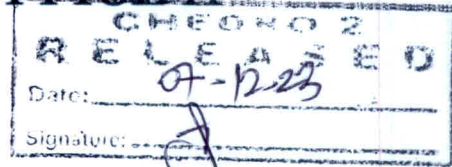

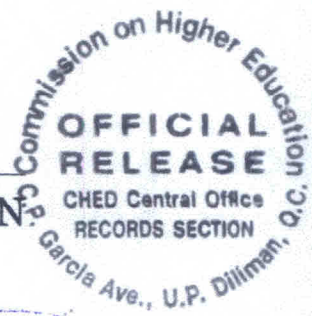

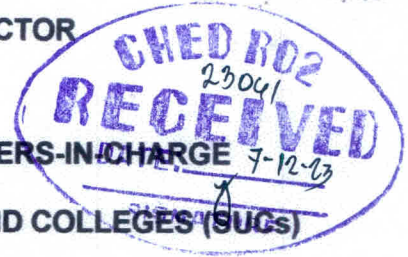

The Commission en banc (CEB) approved the use of the automated system for the faculty submissions and Institutional Evaluation Committee (IEC) evaluations of State Universities and Colleges (SUCs) for standardization and reduction of manual errors, under CEB Resolution No. 357-2023.
