

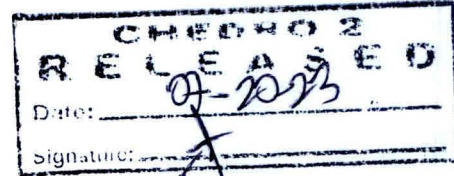

**SUBJECT : PARTICIPATION IN THE DATA RECONCILIATION ACTIVITY FOR THE PHILIPPINE QUALIFICATIONS REGISTER**

CHED Regional Office 2 enjoins the participation of concerned College/University Registrars to the Data Reconciliation Activity between CHEDRO2 and HEIs in Region 2, entitled **Promoting Quality Education: Building the Foundation for the Philippine Qualifications Register** with the theme *Strengthening Qualifications and Recognition of Higher Education in Region 2*, scheduled on **Thursday, 03 August 2023, 8:30AM to 12:30PM** at the CHEDRO2 Auditorium.

The primary objectives of the data reconciliation activity are to:

1. ensure the accuracy and consistency of data pertaining to qualifications, programs, and courses offered by the HEIs within the CHEDRO2 database.
2. identify and address any discrepancies or inconsistencies between the databases of CHEDRO2 and the HEIs.
3. establish a reliable and up-to-date dataset in the CHEDRO2 database that reflects the qualifications and programs offered by the HEIs accurately.
4. enhance the quality assurance mechanisms for data management in both CHEDRO2 and the HEIs.
5. foster effective communication, collaboration, and coordination between CHEDRO2 and the HEIs in maintaining accurate and consistent data records.
6. facilitate the seamless integration of data between CHEDRO2 and the HEIs, contributing to the establishment of the Philippine Qualifications Register.
