In accordance with the pertinent provisions of Republic Act (R.A.) No. 7722 otherwise known as the "Higher Education Act of 1994" and in compliance to the Executive Order (EO) No. 66, s. 2018 - Institutionalizing the Implementation of the Philippine Anti-Illegal Drugs Strategy (PADS), the Commission on Higher Education Regional Office 2 through its program **Preventive Education and** Capacity Building in Higher Education (**PrEaCH**) Against Illegal Drugs will be conducting a workshop and sharing of best practices activity with the theme: "**BALAKAD: Pagkakaisa, Pag-uugnay at Pagsasalin ng Makabuluhang Aktibidad para sa Kagalingan ng Estudyante sa Rehiyon Dos**" on **August 29, 2023, 8:30 AM at CHED Regional Office 2, Tuguegarao City, Cagayan.**

All Public and Private Higher Education Institutions are enjoined to send one (1) Registered Guidance Counselor or if not available, the Dean/Directors/Coordinator of Student Affairs and Services. The officers of the PREACHER02 and the RAPSAS Region 2 shall automatically represent their respective institution. In order to facilitate the workshop proper of the said activity, the participants are enjoined to share activities and practices conducted in their respective institutions which are aligned with the identified areas of intervention of the BALAKAD. Attached is the template to be filled-out for the said activities and practices for your reference.

Food, refreshments, and advocacy materials will be provided during the activity. However, the transportation & accommodation expenses shall be charged against the local funds of the participating HEIs. Officials and employees of SUCs who will participate in this activity should obtain prior approval from the President/Head of their respective institutions. Proper use of government funds in accordance with the Department of Budget and Management (DBM) National Budget Circular No.563 of 2016 and Budget Circular No. 2017-5 is enjoined
