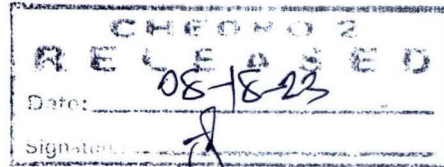

December 2023	Awarding of status
