GUIDE IN SUBMITTING NOMINATIONS

TECHNICAL COMMITTEE QUALIFICATIONS

1) Academic Experts

- a) With at least five (5) year experience in the discipline and has handled administrative positions related to curriculum development and educational administration as college secretary, dean, director or department head
- b) With doctoral degree as defined under the Philippine Qualifications Framework, from the a reputable higher education institution
- c) With scholarly work in the discipline for the past five (5) years
- d) Valid professional regulatory commission license (if applicable)
- e) Affiliated with: HEIs that have programs designated as Centers of Excellence/ Development; private HEIs with Autonomous/ Deregulated Status; SUCs identified by law as National Universities
- f) No pending case involving moral turpitude

2) Industry Experts

- a) With at least ten (10) year industry experience
- b) A practicing professional in the past 3 years
- c) With a bachelor's degree in the discipline earned from reputable higher education institution
- d) Valid professional regulatory commission license (if applicable)
- e) Affiliated with a SEC-registered company that is not in the DOLE blacklist
- f) No pending case involving moral turpitude

3) Government Representatives

- a) An Undersecretary, Assistant Secretary, or Director with recognized expertise in public administration, policymaking, human resource development, research or extension
- b) No pending case involving moral turpitude

4) Professional Association

- a) A member of the governing board of the association for at least five (5) years
- b) Preferably with earned master's degree in the discipline from a reputable higher education institution
- c) Valid professional regulatory commission license (if applicable)
- d) No pending case involving moral turpitude
