### Dear Director Domingo:

First of all, we would like to thank you for your support in the conduct of the "Rapid Survey on Reasons for Student Attrition in Higher Education." Results were shared during the pre-plenary and plenary budget hearings of CHED at the House of Representatives. However, there were still questions asked during the plenary. These were student level data that we usually do not collect, but may need to collect moving forward in order to determine the appropriate interventions or policies that need to be developed. Thus, in preparation for the budget hearing at the Senate scheduled in October 2023, the Office of Planning, Research and Knowledge Management (OPRKM) is again conducting a new round of data collection which we call "Rapid Survey on Profile of Students in Higher Education."
