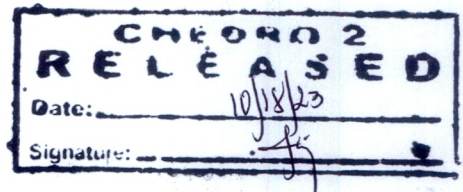

Pursuant to Article X (1) of CHED Memorandum Circular No. 55 Series of 2016 entitled "Policy Framework on the Internationalization of Philippine Higher Education," all Philippine higher education institutions (HEIs) are required to submit to the CHED - International Affairs Service (IAS) a list of their existing cooperation arrangements and collaborative programs.
