This pertains to an email from Mr. Erwin Paala dated 3 November 2021 concerning the November 20, 2023, United Nations International Day of the Child and United Nations World Day of Remembrance for Road Traffic Victims. A copy is attached for your perusal.

As a shared responsibility, the Commission commemorates our brothers and sisters who are victims of road crashes including the children's right to road safety. Per Section 4 (g) of Republic Act No. 11468 or the "National Day of Remembrance for Road Crash Victims, Survivors, and their Families Act" to wit: (g) "The flag-raising ceremonies in government offices the day or week immediately after the National Day of Remembrance shall be dedicated to road crash victims, survivors, and their families, and shall provide a platform for bereaved or affected employees to advocate the need for road safety."

The CHED Central and Regional Offices are directed to implement the above-mentioned provision of law to show our reverence and oneness with the world on this matter.

Furthermore, the CHEDROs are enjoined to invite their respective higher education institutions to collaborate with the Department of Transportation (DOTR) in conducting public awareness campaigns, solidarity marches, and road safety advocacy programs and services.

Lastly, CHED Central Offices and Regional Offices are directed to submit a post-report to the Office of the Executive Director for record and reference.
