All Public and Private Higher Education Institutions are enjoined to send one (1) Registered Guidance Counselor and one (1) student leader to be accompanied by their respective Dean/Directors/Coordinator of Student Affairs and Services. The officers of the PREACHER02 and the RAPSAS Region 2 shall automatically represent their respective institution.

Advocacy materials will be provided during the activity. However, the transportation, food and accommodation expenses shall be charged against the local funds of the participating HEIs. Officials and employees of SUCs who will participate in this activity should obtain prior approval from the President/Head of their respective institutions. Proper use of government funds in accordance with the Department of Budget and Management (DBM) National Budget Circular No.563 of 2016 and Budget Circular No. 2017-5 is enjoined.
