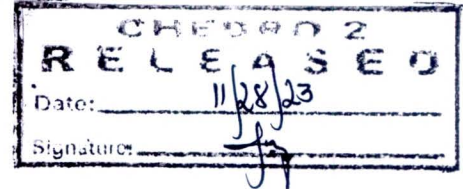

The Department of Environment and Natural Resources-Environmental Management Bureau (EMB) through the Regional Ecology Center (REC) is the lead agency to provide technical and other capacity building assistance and support to the Local Government Units (LGUs) to adopt a systematic, comprehensive and ecological solid waste management plans and programs pursuant to Republic Act 9003.

Republic Act 11898 also known as the Extended Producer Responsibility (EPR) Act of 2022 took effect on August 12, 2022 aims to institutionalize an environmental policy approach for large-scale companies to be environmentally responsible and establish a mechanism for the recovery of their plastic packaging, especially its post-consumer or end-of-life stage. Further, under Section 9 of DENR Administrative Order No.02-2023, the Implementing Rules and Regulations of RA 11898 through the REC shall incorporate institutional mechanisms to provide technical expertise, information, training, and networking services for the implementation of the provisions of RA 9003 and RA 11898.

In this connection, EMB Region 2 will conduct a training for LGUs, academe, national government agencies, industries and other stakeholders to strengthen sectoral collaboration and successfully implement ecological solid waste management programs in the region.
