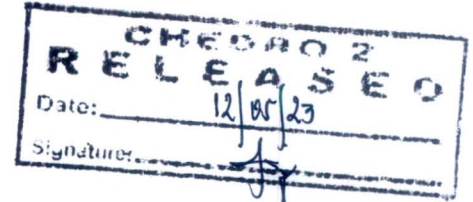

In accordance with Republic Act (R.A.) No. 7722 otherwise known as the "Higher Education Act of 1994," current enactment of Philippine laws, particularly R.A. No. 11036, otherwise known as the "Mental Health Act," R.A. No. 11223 otherwise known as the "Universal Health Care Act," issuance of the Joint Administrative Order (JAO) No. 2022-0001 entitled "Guidelines on Healthy Settings Framework in Learning Institutions," which anchors to the United Nations Sustainable Development Goal #3: Good Health and Well-being; the CHED Office of Student Development and Services (OSDS) shall be conducting a webinar entitled "**GABAY ALALAY: A WEBINAR TO PAVE THE WAY FOR THE SCHOOL COMMUNITY WELL-BEING AND MENTAL HEALTH CARE**" on **December 15, 2023 at 8:00 am to 12:00 nn via online conference application.**

In response to the rising concerns about mental health, the webinar is one of the strategies in creating or improving mental health programs and services and addressing limitations of higher education institutions.
