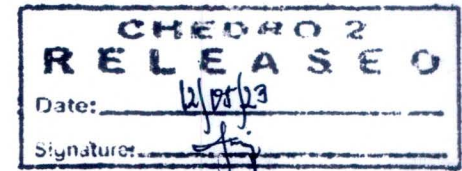

In order to ensure accessibility and inclusivity in quality higher education, the Commission on Higher Education (CHED) issued CHED Memorandum Order (CMO) No. 1, series of 2019 "Integration of Peace Studies/Education into Relevant Higher Education Curricula" and CHED Memorandum Order No. 2, series of 2019 "Integration of Indigenous Peoples Studies/Education into Relevant Higher Education Curricula".

Per Section IVB of the abovementioned CMOs, CHED Regional Offices (CHEDROs) shall closely monitor the offering of IP Studies/Education and Peace Studies/Education, specifically to prepare status report on IP and Peace Studies/Education in the region and present the report during the National Directorate Meeting (NDM), as requested by the Commission en banc (CEB).

In view of the foregoing, CHEDROs are requested to submit and be ready to render a report before the 4th NDM on December 6-7, 2023, on the status of the implementation of CMO Nos. 1 and 2, series of 2019 together with the initiatives on Indigenous Peoples/Studies Peace Studies/Education within your jurisdiction.
